THE FRIGHTFUL RAILWAY ACCIDENT.

The following are the shocking details of the terrible railway disaster which occurred on the night of Friday, 29th ultimo, near Ashabula, Ohio, on the Lake Shore Road.

New York, Dec. 31.—A special from Ashabula says that the storm there yesterday was so severe that very few business places kept open after four or five o'clock, and the trains from all directions were several hours behind time. About 8 p.m. the village was aroused by a general fire alarm, and word soon spread that passenger train No. 5, from the East, had gone through the high bridge over Ashabula river, with a large number of passengers, and the whole train was on fire.

A lurid glare in that direction confirmed the report, and in spite of the terrible night the whole village and all the fire engines were soon en route to the scene of the disaster. The train was due at Ashabula at 5.45, and was nearly three hours late. It had eleven cars, including one drawing-room car, three sleepers, one smoking car, two coaches, and a baggage car. It was drawn by two engines, the Sociates ahead, followed by the Columbia, No. 300.

Daniel McGuire, engineer of the Sociates, relates: The train was running slow, and just as they had fairly entered the river, six or seven feet below the high bridge, the engine was pulled back nearly to the edge of the broken span before the coupling between the Sociates and the Columbia broke, and the whole train was precipitated with terrific force into the river, six or seven feet below the high bridge, and lay there in use about 15 minutes.

It is supposed the heavy draughts must have thrown the cars from the track, causing the cold iron to snap.

The terrible scene below beggars all description. The span is about 100 feet wide, and through the space below flows the river, about four or five feet deep, at this time thickly covered with ice. Into this space was the eleven cars, and the whole train was precipitated, the fall of course breaking through the ice and shivering the cars as if a magazine of nitro-glycerine had exploded beneath them.

The seven passenger coaches alone contained 103 adults and a number of children. In the drawing-room car bound for Cleveland were nine persons, all supposed to have perished. In the two sleeping cars were 45 passengers. Most of those in the forward cars were saved with injuries more or less severe. Within a very few moments after the crash the flames burst out from nearly every car. Fire help was at hand the moment the train was precipitated, and as to which should devour the greater number of human lives.

Mr. Frank Belknap, who was the earliest at the scene, says the pitiable cries for help from the victims were heard for miles around. Here was a young and finely dressed girl, about ten years old, struggling in vain to release her hand from the weight which was crushing her slender frame, and close behind her were flames shooting up like a giant.

There was a fine appearing gentleman of middle age sitting bolt upright in his seat and unable to extricate himself, calmly awaiting the flames which soon defined his victim. There were bodies floating out from the wreck and others not yet strangled by the icy flood were attempting to reach the shore trying to extricate the living.

A crowd soon made their way to the burning debris, and with axes and ropes extricated many persons who were placed on stretchers and taken to the top of the hill, where the best of assistance awaited them. The hotel at the depot were soon filled, and private houses were thrown open throughout the town. The surgeons of the town rendered all the assistance in their power, but many perished during the night, notwithstanding the best of care. Others are now lying in a suffering condition. Fully one hundred persons were killed in this terrible disaster.

The Commercial's special from Cleveland says as killed cannot number less than 100, and may reach 120, only 34 out of 170 or 174 passengers have been found. Rev. A. A. Washburn, Rector of Grace Church, Cleveland, is among the lost. 30 of the wounded have been brought to this city, and are now lying in the hospitals. The mails and baggage have all been lost. Most of the dead men seem to have been from New York, New England, and Illinois. The majority of the bodies were reduced to ashes. Those which were saved were buried in the water. The engine lies completely wrecked with wheels apparently at the bottom of the ravine. The wreck will not be cleared before Sunday.

Ashabula, O., Dec. 31.—During the entire day, over 100 men have continued the labor of clearing away the debris of the wrecked train and bridge in Ashabula river. The laborer were two more bodies and some unrecognized buried pieces of flesh, and the engine is gaining ground that many passengers were totally or almost completely consumed. Intense excitement is shown by the people, and many have arrived here from the East and West.

West in search of information regarding missing friends, but little satisfaction can be given them. Telegrams are also being constantly received asking news of absent ones. The bodies in the freight house containing bodies were numbered today, and white paper labels placed on those identified. There are 30 bodies or masses of charred and blackened flesh in boxes. A coroner's jury have been taken out, and will investigate the horror thoroughly.

DANGER IN TOYS MADE OF CAOUTCHOUC.

Some startling revelations have recently been made in reference to what is known as vulcanized india-rubber. This substance is ordinarily composed of india-rubber mixed with from ten to twenty per cent. of sulphur at a temperature of about 300 degrees Fahrenheit. It is customary, however, to add a certain proportion of lead or zinc oxide, by which means the vulcanite acquires additional weight and solidity. Now the fact exists that in many instances the human system, when absorbed, and it was in consequence of the complaints which were everywhere made some time ago that caoutchouc suckers containing zinc have been universally condemned as sucking-bottles for infants.

A case, however, has recently come to light in Berlin which shows that a similar danger attend the use of toys made of caoutchouc, such as dolls, animals, &c., when used as conditions. In this case, a child, who had been in the habit of sucking on a doll, died of its mouth, was taken ill. The doll, when placed in vinegar, became coated with incrustations of zinc oxide, the substance of which was zinc oxide.

SHREBURN.
Shelburne, Jan. 24.—The schooner, *Eliza Jane*, of Gloucester, Griffin, master, came on Jig Rock last night and sank. She is a total wreck. The crew were saved.

ST. JOHN, N. B.
St. John, Jan. 24.—Thomas Edwards, of Quebec, was before the Police Court today, charged with embezzling \$180 belonging to the International Express Company. He is to be examined on Monday.

An inquest was held this afternoon on the body of an infant found yesterday. Some of the clothes were identified and traced to a young woman in Leveson Cove, but the evidence did not show that she was the mother of the infant.

OTTAWA.
Ottawa, Jan. 24.—The following resolution will be introduced in the Ontario Legislature by Clark of New York: "That the interests of society at large require that stringent measures be used to repress vice and crime of every description, especially in favor of the law-abiding population of towns and cities, therefore resolved, that a committee be appointed to examine into the condition of the pauper poor of Toronto, with power to select for persons and papers, with a view to legislative action, if deemed applicable to the case."

Mr. Clark also gave notice of motion as to the constitutional validity of acts of the Ontario Legislature, which regulate, restrict or prohibit the sale of or traffic in spirituous liquors. The question is to be submitted to the Supreme Court of Canada.

This motion causes considerable comment and is regarded as reactionary.

W. H. Baldwin, a leading lumberman here, failed today; liabilities over one million dollars.

MONTREAL.
Montreal, Jan. 24.—The Jacques Cartier contesting local election case was argued today in the Court of Review, and taken on *delibere*.

Today Judge Tupper gave judgment on \$27 against the *Alma* Steamship Co. for the value of the contents of a trunk lost on the passage from Liverpool to Portland a year ago.

Flour market quiet; prices nominal; unchanged.

It is said that Judge Wilfred Davidson is coming up from Quebec to replace Judge Monro.

The *Witness*, in an article on the Freeman's attack on the *Herald* and *Norfolk* *Mail*, denounces some severe lines on both sides, charging the *Witness* with not having been sufficiently pronounced on ecclesiastical questions.

The chess tournament is now going on.

It is understood that as soon as Mr. Tupper's motion is made, the government of the *Witness* will be asked to leave the case before the Supreme Court at Ottawa, he will be nominated to the vacant judgeship in the Superior Court at Quebec.

UNITED STATES.
New York, January 24.—Prominent New Yorkers are moving for economy in the municipal government. This is in view of the situation in Mexico, and is ruling with prudence and courage.

The Presidential compromise is warmly debated in the U. S. Senate. Most of the Senators, and other radical Republicans oppose it.

Old wind from the northeast. The New York *Herald* predicts that the Presidential compromise will pass the Senate by three-fourths majority.

The report of the Congressional committee on the Louisiana election is expected to be made during the present week.

RENOVE.
London, Jan. 24.—Fifteen miners were burned to death in a colliery near Bolton.

A despatch from Constantinople says it is absolutely certain that Russia, since the failure of the Conference, has again endeavored to negotiate a special treaty with Turkey. Midhat Pasha opposes such a course.

It is stated that the Porte intends to request France to send military officers to Constantinople to instruct the gendarmerie, and also to ask England for the assistance of competent financial administrators, with a view to reorganizing Turkish finances.

TOO EARLY DISCOURAGED.

FENCE POSTS TO END DOWN
At a discussion at the Centennial Grange Encampment, I see that many advised setting fence posts top-end down, although no one could give any reason for their lasting longer in that position. This question may often have arisen in the minds of the readers of the *Country Gentleman*. A study of vegetable physiology led me to try several experiments. Many years ago I threw light upon this question. The sap of a sapwood goes up in the top-end of the roots to the leaves.

Yellow will give a light, lemon-colored tint to the wash. A cheap paint for the floor can be made, which a strong, smart woman could apply to any floor, 5 pounds of French ochre, $\frac{7}{8}$ of a pound of glue, and a gallon of hot water. Dissolve the glue in a small quantity of hot water; when wholly melted add the rest of it, stirring it slowly until well mixed. Then stir in the ochre, and apply while hot, with a good sized paint brush. When well dried apply 1 or 2 coats of boiled linseed oil. This paint dries very quickly, hardening in fifteen to twenty-four hours.

GENERAL NEWS.

The Crimean war cost England 22,000,000,000 and France some 10,000,000,000.

The locomotive engineers and firemen of the New Brunswick Railway have secured a strike for increased wages on Monday last. It is said the company was prepared for the movement.

The steam train, with a cargo of iron ore, from Lunenburg for Halifax, arrived at Bonaventure on the 5th inst. in distress, and lay over. One of the crew died, and the others were badly frozen.

It is a curious fact that among the few who escaped at the Ashtabula horror was a man who was in the Brooklyn theatre at the time of the great conflagration, whose clothes were singed as he fled from the flames.

Small Pox in London.—The ravages of the small-pox are again increasing. There were 103 deaths from the disease in London last week, being the largest number during the present epidemic, excepting the first week of January.

The Birmingham, England town council have adopted a motion to introduce the Goldenberg experiment of obtaining a municipal monopoly in intoxicating liquors in that city. John Bright is among the earnest advocates of the scheme.

The steamer *Battara*, from New Orleans for Liverpool, was burned at sea, February 6th. The passengers and crew, in boats, were picked up by the tugboat *Dorothy Thompson*. The steamer and cargo, principally cotton, is valued at half a million dollars.

At Mannheim, Germany, there is no manufacturing industry, but there are thirty steam engines, a capital of three million dollars and its product of colors and soda is about seven million a year. It is the largest establishment of the kind in the world.

The French Government is about to sell at auction the last four balloons which were constructed during the siege for escaping from Paris. These balloons are considered unfit for service, and the balloon committee will replace them with new ones, an appropriation of \$14,000 having been made in the budget of 1877 for military ballooning.

A cat nearly 100 years old has turned up at Cambridge, New South Wales. The animal is said to have been brought from England in the *Endeavour*, one of the three ships which accompanied the first fleet of convict ships which anchored in Botany Bay Jan. 26, 1788, and is the sole survivor of 77 quadrupeds transported on that vessel.

The case of reprobating and repatriating the colonies of the Peace Convention at Paris, which has been the subject of the communists during the last revolution, is reported at \$14,775. The painter, Courbet, who was mainly instrumental in causing the overthrow, is made responsible for the money as to his property, which is considerable, will allow.

B. S. Thompson, a young lawyer of Newcomb, temporarily teaching school in that county, Illinois, died last week of pneumonia. Just before his death he was taken sick in bed and died in a few days. He was a bachelor and during his illness, he would talk of it in his delirium, and met over his unfinished condition frequently. This continued until near the hour of his death. Two hours before he died he called for pencil and paper, and in a very few minutes worked the problem and demonstrated its correctness. Having done this, he handed the paper and pencil to his attendant, remarking as he did so, "I think I may work in one, and I am ready to die." He laid himself back on his pillow, and in two minutes thereafter was a corpse.
